

GENERAL INFORMATION

REMOVE™ Spray Tank Cleaner is a superior, concentrated cleaning material. Cleaning your tank is not always as easy as it may seem. With the tremendous amount of chemical and adjuvant combinations, add to this the difference in water quality and fertilizer components, you have a large range of residues that can be formed. This creates a major challenge for the cleaner concentrate. **REMOVE™** has been formulated to clean most any residue. **REMOVE™** is approved for removal of DuPont® "SU" Herbicides.

DIRECTIONS AND CONCERNS

1. Determine what chemical you have sprayed.
2. Read the corresponding chemical label for directions on cleaning.
3. Follow these guidelines for proper removal of the residue.
4. If these instructions require the use of a tank cleaner, **REMOVE™** can be added to the cleaning solution in the appropriate concentration.
5. To determine the proper rate to add, consider the chemical to be removed, past experience, and whether there is any visible residue in the tank.
6. Normally, easier to remove chemicals can be cleaned with a dilution of 1 qt./100 gl. Harder to remove residues may require higher concentrations i.e. 2qts/100 gal. or more.
7. Make sure that the cleaning solution contacts all internal tank and hose surfaces. Flush. Rinse and dispose of all rinsate properly.

STORAGE AND DISPOSAL

PROTECT FROM FREEZING: Store above 32°F. Do not reuse empty container. Dispose of container in a safe manner in accordance with federal, state, and local regulations.

NOTE

The solution should be allowed to remain on all surfaces to be cleaned so that the solution can have time to penetrate all existing residues. This process can take as little as a few minutes, to as long as a day depending on the physical state of the deposit. Since it is impossible to know how long to wait, a person must use their best judgement. Since this is not 100% certain, you must determine whether the last rinsate is "safe". You can do this by applying a test solution to the next crop and determining by visual symptoms if it is safe to be used.
